Introduction

Through an increasingly active participation in the four Business Forums of the Americas already held and an expressive investment in the elaboration of position papers, the Brazilian business people have indicated the desire to influence the process of construction of the FTAA.

The formation of the Brazilian Business Coalition, effected in 1997 during the process of preparing for the III Business Forum of the Americas, involved business people and business organizations of the most diversified segments of the economic activity in Brazil, and pointed to a wide consensus amidst the Brazilian business sector concerning the visions and recommendations expressed in this document.

Brazilian business people have been accompanying with concern the impact of the international financial crisis on the trade flows. Protectionism pressures have been popping up with growing intensity in the developed countries. For Brazil, as a global trader, the deterioration of the world trade system is a negative trend. In this context, Brazilian interests in the negotiations of the FTAA depend basically upon the integration model that will emerge. In the Brazilian vision, this model should contemplate:

- the conformity with the WTO rules;
- the coexistence with subregional and bilateral agreements in effect in the hemisphere, as long
 as those agreements have different nature or establish rights and obligations that are not
 covered or surpass those established in the FTAA.
- the establishment of a framework of liberalization and of policies convergence that does not imply in strong discrimination of third countries as it relates to trade and investments;
- the adoption, on the trade liberalization programs, of the principle of asymmetric reciprocity
 or of rules that allow differentiated convergence schedules, according to the degree of
 development of the economies and of the asymmetries that do exist among them;
- the reduction of the Brazilian exposure to the unilateral mechanisms of discrimination used by the United States;
- the achievement of substantive improvement in the markets access conditions in the hemisphere for sectors presently affected by non-tariff barriers and tariff peaks;
- the establishment, in the initial phase of the negotiations, of an agenda of business facilitation
 measures that does not imply in legislative changes, but that is able to grant greater
 transparency to trade policies and practices of the countries involved.

Negotiations for the construction of the FTAA should be grounded on the principles of balance as regards the negotiating process and its results, gradualism with respect to the development and progress of the negotiations, and simultaneity as to the application of the different partial understandings, which are to form part of a general Agreement, in consonance with the principle of a single undertaking.

The Brazilian business sector wishes to continue its active participation in and influence of the negotiating process. To that end, it recommends that:

- the governments develop transparent mechanisms for the diffusion of information on the course of the negotiation to its respective private sectors;
- the mechanisms for consultation and participation of the private sector in the hemispheric area

should be improved through the invigoration of institutional mechanisms for consultation and coordination of the private sector with the governments. In the course of the negotiation, it is desirable to hold at least a meeting or an annual seminar among government and business representatives for each important subject on the negotiating agenda.

Herein below are enumerated the recommendations of the Brazilian business people for the negotiations that will be taking place in each one of the negotiating groups that make up the process of negotiations. At the end of this document are also listed the business facilitation measures supported by the Brazilian Business Coalition.
